



## Proposed Schedule Adjustments for October 15, 2012

Please read the following service highlights and be sure to pick up a new schedule for accurate service times.

“**Peak**” time refers to approximately 5:00-9:00 AM and 3:00-7:00 PM.

“**Midday**” refers to approximately 9:00 AM-3:00 PM.

“**Night**” service refers to approximately 7:00 PM and later.

“**Outbound**” generally means away from downtown.

“**Inbound**” generally means heading towards downtown.

**2**

**Route 2 WEST CHATHAM-** Additional trips in morning and evening peak hours as well as service in the midday.

**3A**

**Route 3A AUGUSTA AVE/GARDEN CITY-** MON-FRI hours extended from 6:00 AM – 11:00 PM, leaving downtown every hour on the hour. First morning trip on SAT served by **3B** now.

**3B**

**Route 3B AUGUSTA AVE/GARDEN CITY/HUDSON HILL-** More consistent service to Tuten & Rankin and Carolan & Bay. MON-SAT departure times from Broughton & Montgomery shifted to be at half-past every hour. Last trip MON-FRI departs downtown at 8:30 PM. SAT service ends at 3<sup>rd</sup> & Minus at 10:00 PM.

**4**

**Route 4 BARNARD-** Provide more service to Montgomery Landings and Lamar & Dixon. MON-SAT midday service shifted from every 30 minutes to hourly. Added trips on SUN with last trip outbound ending around 6:00 PM at Chatham Plaza; service inbound to downtown can be provided by the **27 Waters**. Remember to request a free transfer before paying your initial fare on the **4**.

**6**

**Route 6 CROSS TOWN-** MON-SAT departures from Hodgson Memorial shifted to improve connections with the **17 Silk Hope**. MON-SAT service will end at 9:17 PM at Super Walmart on Highway 17; service inbound to downtown can be provided by the **17 Silk Hope**. Remember to request a free transfer before paying your initial fare on the **6**.

**10**

**Route 10 East Savannah-** Additional trip outbound MON-FRI leaving downtown at 9:35 PM.

**11**

**Route 11 CANDLER-** Added service to Walmart on Montgomery Cross on every trip plus additional trips to Williams Court and the Rose of Sharon Apartments. Remove the 3:00pm trip starting from Riverview Nursing Home as Riverview will now be served on outbound trips only.

- 12** **Route 12 HENRY-** MON-FRI service will end at W. 51<sup>st</sup> & Hopkins at 10:33 PM.
- 13** **Route 13 COFFEE BLUFF-** Reinvested roundtrip departing from Hodgson Memorial & Mall Way at 8:30 AM to add service to Heritage Park Nursing Home: will be served on every trip.
- 14** **Route 14 ABERCORN-** Increased service to Rose of Sharon Apartments, Williams Court, and Candler Hospital. MON-SAT midday service shifted from every 30 minutes to hourly, with service ending at 8:52 PM at Broughton & Montgomery. **Route 114X Abercorn Express** will provide service to Savannah Mall area throughout the day and at night.
- 114** **Route 114X ABERCORN EXPRESS-** Increased service to St. Joseph's Hospital and Phillips-Winters Apartments. MON-SAT midday service shifted from every 30 minutes to hourly and will honor all stops between Broughton Street and Oglethorpe Mall. Increased night trips MON-SAT.
- 17** **Route 17 Silk Hope-** Increased SAT-SUN service to Detention Center.
- 20** **Route 20 MONTGOMERY/SKIDAWAY ISLAND-** Reinvested 8:30 AM and 6:30 PM trips and increased service to LaRoche & Hopecrest.
- 25** **Route 25 MLK JR BLVD/WESTLAKE APTS-** MON-FRI additional trips to Oaks at Brandlewood, Probation Office, and Westlake Apartments.
- 27** **Route 27 WATERS-** Additional trips to Candler Hospital and Memorial Hospital.
- 28** **Route 28 WATERS-** Additional trips to Candler Hospital and Memorial Hospital. Streamlined inbound routing from Walmart on Montgomery Cross to turn right up Waters Ave.
- 29** **Route 29 W. GWINNETT/CLOVERDALE-** Additional trips to Lynes Ave.

No changes are planned for the **24 Savannah State/Island Towne Centre** and the **31 Skidaway/Sandfly**.
